In 2022, ATX Kids Club provided 368 youth from 51 different zip codes with an opportunity to build their confidence, develop a sense of independence and explore the Central Texas region through our educational field trip adventures program. There were a total of 185 campers that attended more than one program. We provided 11 weeks of Summer Camp with 414 openings filled with 287 unique campers. 24 campers attended summer camp for more than one week. We provided 32 School Holiday adventures with 227 openings filled with 101 unique campers. ATX Kids Club also hired its first full-time program manager in 2022.
